To achieve that, among others, appropriate, accurate and strong statistical legislation are needed. In this context, it may be worth mentioning that Principle 7 of the UN Fundamental Principles of **Official Statistics (FPOS) clearly states that "The laws, regulations** and measures under which the statistical systems operate are to be made public."

The motivation behind this Principle is that transparency of legislation, rules and measures pertaining to the operation of the statistical system is a precondition for maintaining trust in the official statistics. This indicates that modernising and updating the statistical legislation is critical to the effective performance of the national statistical system.

Dear Participants

As we all aware, the 2030 Sustainable Development Agenda has emphasized, through the SDGs, the demand for new data, which requires the national statistical systems around the world to operate in larger data ecosystem; posing unprecedented technical and financial difficulties. As an example on these difficulties, is that many countries, during the COVID-19 pandemic were facing the challenge of adjusting their data governance and management to a digital society, which requires strong appropriate and clear new statistical laws.

Against this background, and in line with the Programme of Action 2021-2025 of the OIC Statistical Commission Strategic Vision 2030, we, in our capacity as the Secretariat of OIC-StatCom, organise this Workshop with a view to provide a platform for sharing experiences and best practices among the NSOs of the OIC countries and the relevant international organizations in the domain of modernisation of legal and institutional frameworks of official statistics.
