Progress on the implementation of OIC-StatCom SV 2030 will be reported during the 10th Session of OIC-StatCom in October 2021.

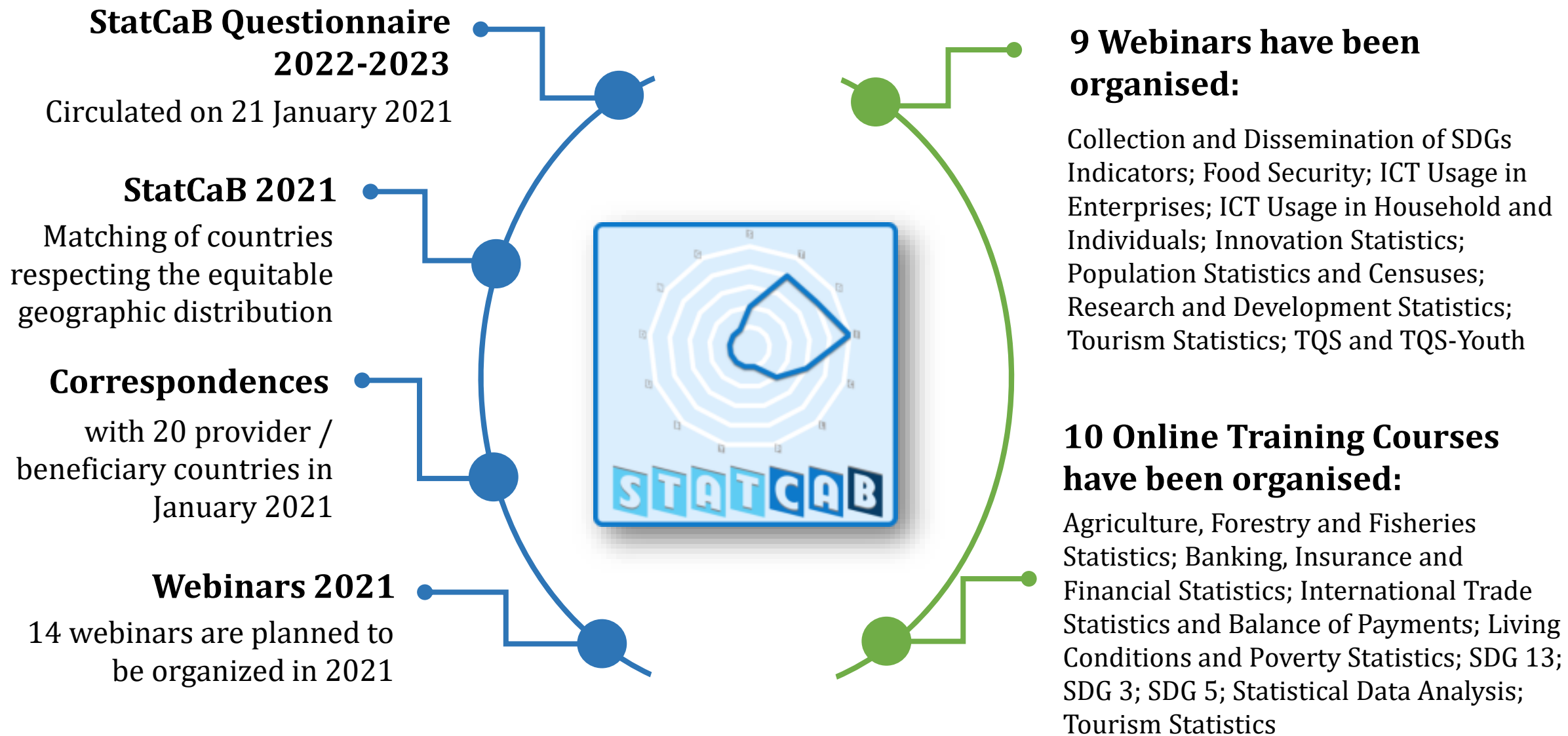
Implementation of the OIC-StatCom Strategic Vision 2030 and the Programme of Action 2021-2025 (Resolution #1)

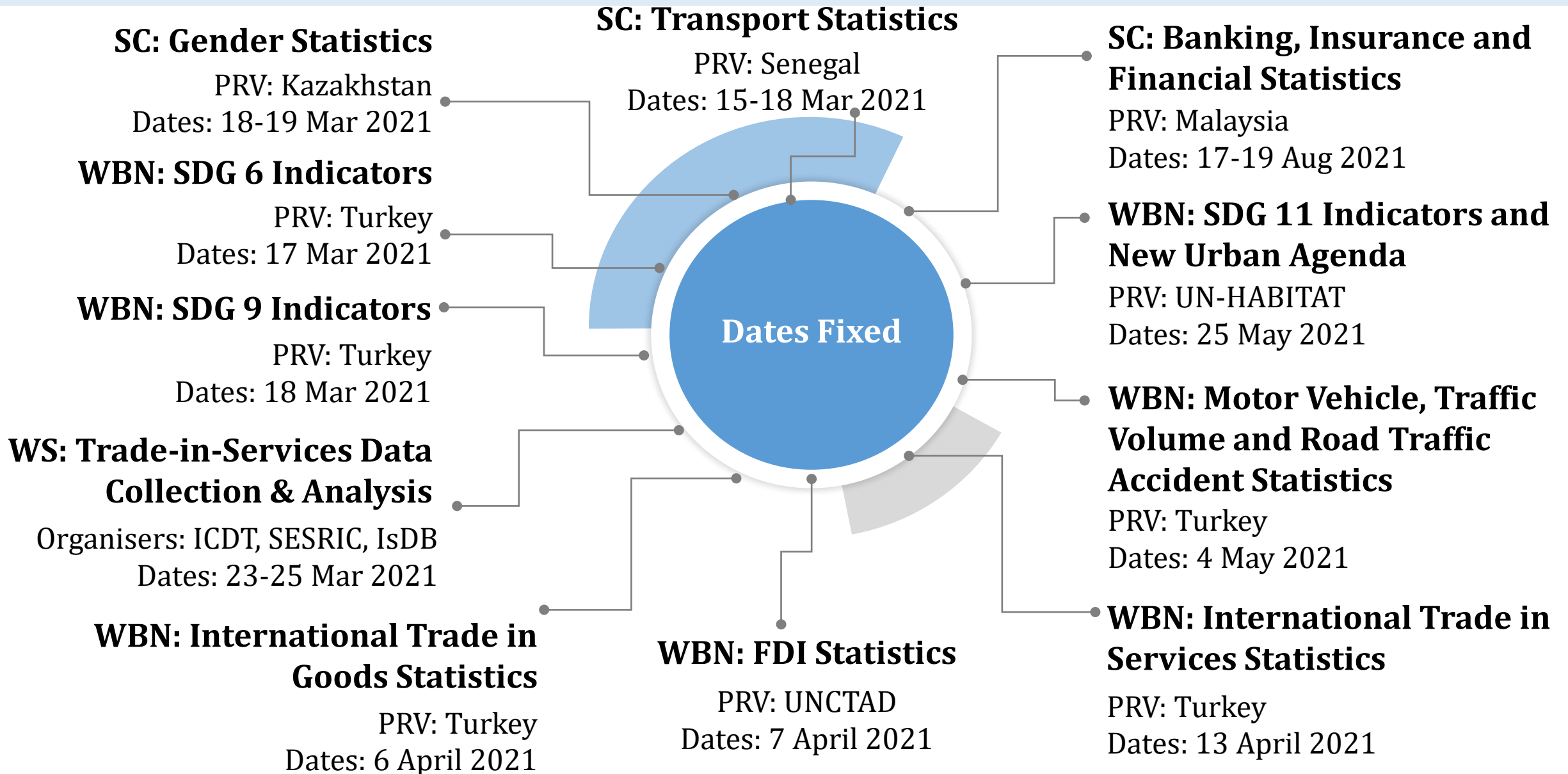

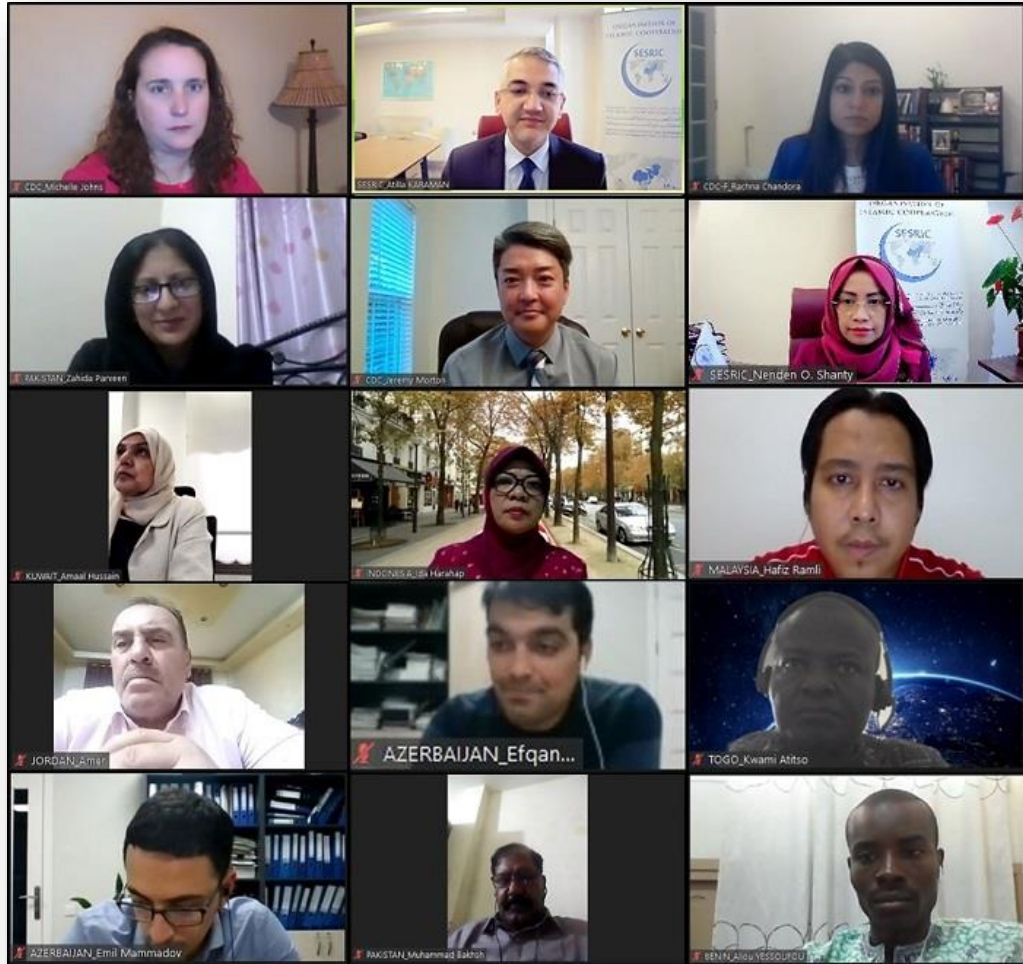
