# REPORT

THIRD MEETING OF THE MONITORING AND ADVISORY  
COMMITTEE OF THE OIC-VET PROGRAMME

(TEHRAN, 17–18 JULY 2011)



**Ankara, August 2011**

## **I. BACKGROUND**

1. The Third Meeting of the Monitoring and Advisory Committee (MAC) of the OIC-VET Programme was held in Tehran, Islamic Republic of Iran from 17 to 18 July 2011.
2. The main objectives of the Meeting were:
  - To review the progress of the actions and activities accomplished since the Second Meeting held in Antalya, Turkey on 11–12 May 2010;
  - To discuss the modalities of closer collaboration in ongoing OIC-VET projects and programmes;
  - To draft an action plan for the coming period; and
  - To increase the involvement of NFPs into the ongoing projects/programmes.

## **II. ORGANIZATION OF WORK**

### **A. Attendance**

3. The Third Meeting was attended by representatives of the following OIC Member Countries:

## **B. Documentation**

5. The documentation of the meeting consisted of the Draft Agenda and Programme. The meeting was also provided with the Implementation Report of the Vocational Education and Training Programme for OIC Member Countries (OIC-VET), programmes and reports of the previous MAC Meetings, updated brochure of the OIC-VET Programme and introductory flyers of International Student Internship (OIC-ISIP) and Ismek Master Trainer (IMTP) Programmes.

## **III. OPENING SESSION**

6. The Opening Ceremony of the Third MAC Meeting was held on 17 July 2011 under the chairmanship of Dr. Kourosh Parand, Deputy of Training at TVTO and the Chairman of the Third MAC Meeting. Following the recitation from the Holy Quran, Dr. Parand welcomed all participants and emphasized the importance of OIC-VET Programme for all OIC Member Countries.

7. In his inaugural address, H.E. Prof. Abdolraosul POURABBAS, Deputy Minister of Labor and Social Affairs and President of Technical and Vocational Training Organization (TVTO), first welcomed the delegates of the National Focal Points of the OIC-VET Programme and thanked the Republic of Turkey to host the first and second Meetings of MAC. He further stated his hope that the Third MAC Meeting would be an important step in achieving the long term objectives of the Islamic Countries in increasing the capacity of economic institutions, scientific development and skills learning abilities through life-long learning.

8. H.E. POURABBAS continued his statement by pointing out the significance of innovation, technology and science for sustainable development, economic growth and welfare of the Islamic Countries, especially with the shift from the resource-based economy to knowledge-based economy. In this regard, H.E.Prof. Abdolraosul POURABBAS stressed the importance of technical and vocational training as the most important tools for the policy of innovation and technology.
9. Before concluding his remarks, H.E. Prof. Abdolraosul POURABBAS stated Islamic Republic of Iran`s readiness in relevant fields of vocational education and training for the enhancement of cooperation at the level of OIC Member Countries.

10. H.E. Dr. Savas ALPAY, Director General of SESRIC, made a statement at the Opening Session. He expressed his special thanks to the Technical and Vocational Training Organization (TVTO) for hosting the Third MAC Meeting in Tehran and for the warm hospitality. He also expressed his thanks to the delegates for accepting SESRIC`s invitation and designating their time to attend the Meeting.
11. In his speech H.E. Dr. Savas ALPAY elaborated on the milestones achieved in the conduct of the various activities under the OIC-VET Programme. H.E. Dr. Savas ALPAY emphasized the role of OIC-VET Programme in establishing a common platform for exchange of knowledge and experience through cooperation and collaboration among OIC Member Countries in order to improve the quality of vocational education and training in the public and private sectors. He commended the projects in which SESRIC, as the Executive Organ of the OIC-VET Programme, concerned OIC institutions and public and private partners have been working together to support and enhance the opportunities for individuals to develop their knowledge and skills.
12. H.E. Dr. Savas ALPAY also shared his belief that the Third MAC Meeting would provide an invaluable platform to discuss further ways of improving the existing programmes under OIC-VET, besides identifying new potential areas for further collaboration. He, therefore, requested the delegates and representatives of relevant OIC institutions at the Meeting to support the OIC-VET Programme and to actively get involved in the ongoing projects for their increased success.

13. Lastly, H.E. Dr. Savas ALPAY and H.E. Prof. Abdolraosul POURABBAS presented their gifts to each other. Following the award ceremony, the Session adopted the Draft Agenda of the Third MAC Meeting and elected the Chairman, Vice-Chairman and the Rapporteur Countries. Iran, Turkey and Pakistan were elected as the Chairman, Vice-Chairman and Rapporteur of the Meeting respectively.

#### **IV. WORKING SESSIONS**

##### **Working Session I: Review of the Progress in the implementation of the OIC-VET Programme since the Second Meeting of the Monitoring and Advisory Committee (MAC)**

14. The session started with an OIC-VET visual presentation focusing on the aims and importance of the Programme. After the short introduction of the participants by Mrs. Hatice Ilbay Soylemez (SESRIC), Mrs. Melek Ates Tasci (SESRIC) briefed the participants on the OIC-VET Programme and pointed out to the activities completed by SESRIC since the Second Meeting of the MAC. Mrs. Tasci mentioned the Official Launch of the OIC-VET Programme by H.E. Abdullah GUL, President of the Republic of Turkey and Chairman of the COMCEC, at the COMCEC Economic Summit held in Istanbul on 9 November 2009. Mrs. Tasci also informed the participants of the governance, previous MAC Meetings, objectives, beneficiaries, implemented activities, capacity building programmes and training opportunities of the OIC-VET Programme.
15. Following the presentation of Mrs. Melek Tasci, Mr. Mehmet DOGAN, education director at Istanbul Metropolitan Municipality made a presentation on “As an Adult Education Application: ISMEK, Istanbul Art and Vocational Education Courses”. As an OIC-VET partner in the “ISMEK Master Trainer Programme (IMTP)”, Mr. DOGAN briefed the participants about ISMEK and explained in details the working mechanism of the programme.

**16. The Meeting expressed appreciation of the above SESRIC activities and adopted the following decisions and recommendations:**

- Inform National Focal Points (NFPs) about the resources available in terms of finances and capacities to execute the OIC-VET projects;
- Inform all NFPs before any implementation regarding the OIC-VET projects;
- Prepare Portal announcements of recent and upcoming OIC-VET activities;
- Prepare schedules for the OIC-VET projects;
- Develop projects targeting unemployment and considering the market needs;
- Increase the volume of trainings and Training of Trainers (ToT) courses;
- Develop e-learning module to share the trainings on the virtual base among OIC Member Countries;
- Conduct research projects studying the training needs, strategies and weaknesses of VET systems in OIC Member Countries;
- Publish a statistical yearbook on TVET in OIC Member Countries to identify the current capacities and weaknesses of the countries;
- Share the resources to strengthen the VET systems in low income countries;
- Establish an email group for NFPs for technical support and better communication.

**Working Session II: Discussion on higher involvement of NFPs and OIC Organs in the implementation of OIC-VET**

17. The session started with a recitation from the Holy Quran. Afterwards, representatives of the member countries and OIC institutions briefed the meeting about the latest developments in the field of vocational education and training in their respective countries and discussed several ways and means of increasing the involvement of NFPs and OIC institutions in the implementation of OIC-VET Programme.

18. Mr. Mohamed Hashim (Maldives NFP) made an introductory presentation on the history, current situation, challenges and future of VET in Maldives and briefed the Meeting about the recent preparations of Skills Training Program, a new initiative of the government of Maldives to tackle the increasing number of youth unemployment and foreign expatriates in the country. He explained the need for competency based trainings according to market needs, skill standards and curricula to improve the quality and employability of trainings. He further requested an active collaboration within the OIC-VET Programme to improve the educational, employment and community services in the member countries.
19. Mr. Ahmad Mukhtar (Pakistan NFP) informed the meeting about the structure and mandate of National Vocational and Technical Training Commission (NAVTTTC) of Pakistan and their efforts to enhance the VET activities in Pakistan which have been promoted through the National Skills Strategy (2009-2013). He further briefed the Meeting about their collaboration with other countries and international organizations with a view to increase the total capacity of VET in Pakistan. He lastly remarked on the similarities of challenges and responses across the countries and stressed the importance of closer cooperation between the member countries.
20. Mr. Huseyin Acir (Turkey NFP) made a presentation where he summarized MEGEP, METEM and UMEM Projects and reflected upon the questions of what is distinctive about them and in which areas of the projects may the cooperation between member countries be enhanced. He also briefed the participants about the VET system and the state of VET capacity in Turkey as well as the lessons learnt from their experiences for matching the existing competences and identify possible areas of future cooperation. He further proposed the development of curriculum and training materials, the exchange of students and trainers through sister schooling and training of trainers (ToT) among OIC Member Countries.
21. Mr. Sameh Hussein (IDB Representative) briefed the participants on Education for Employment (E4E) project which aims to contribute to the solution of the unemployment problem in Arab countries. He further pointed out the findings of the research that was conducted jointly by Islamic Development Bank and World Bank. He also mentioned proposals that addressing the gap between knowledge and skills in trainings.

22. Mr. KouroshParand (Chair) summed up all the presentations and invited participants to give their remarks at the end of the session.
23. Mr. Reza Bajoulvand (Iran NFP) informed the participants about the gender equality in accessing vocational education and training in Iran and stated its readiness to help other member countries with the support of IDB.
24. Mr. Mukhtar Ahmad (Pakistan NFP) stressed the need to formulate the OIC-VET Programme as a comprehensive platform on the EU model and suggested to constitute a core group out of member countries who would study various collaborative models around the world, formulate a proposal for establishing a platform which can serve as a common accreditation and certification mechanism and suggest policies and strategies for TVET in various countries. He further underlined that only such a platform can integrate the TVET systems of the member countries and help in mutual recognitions of qualifications through common evaluation tools.

### **Working Session III: Discussion of Potential Project Proposals**

25. The session started with a short documentary on Iran focusing on its history, culture and potentials. The documentary was followed by a presentation on TVTO. Mr. Reza Bajoulvand (Iran NFP) informed the participants on the education system in Iran and in TVTO, its target groups, its collaboration with the national and international bodies, sub-offices and structures, TVTO policies and National Qualifications Framework.
26. He also stated the need to organize international skill competitions between OIC Member Countries to give the members the opportunity and a platform to exchange information as well as to display their skills. He lastly stressed the readiness of Iran to host these competitions with the collaboration of other countries.
27. Mr. EminTarikArgit (MUSIAD) briefed the Meeting about the framework and working mechanism of International Student Internship Programme (OIC-ISIP) and stressed the importance of public and private partnership to increase the quality of vocational education and training and to provide the integration of labor market and vocational training.



28. The participants were then separated into three groups to identify the potential projects for collaboration and to finalize other proposals. Mr. Ali Isler, Expert at COMCEC Coordination Office, briefed the participants about the criterion for project proposals and financing mechanism of IDB for the OIC Member Countries. Representatives of the groups informed the Meeting about their discussions and proposed the following areas and projects promoted by the national focal points for consideration and implementation;

- Mobile Training
- Tourism and Hotel Management
- Virtual Training
- Training of Trainers
- Port Handling and Shipping

#### **Working Session IV: Next Steps and Action Points**

29. Mrs. Tulay Alpman (Ministry of Labor and Social Security of Republic of Turkey) made a presentation on the activities and efforts of Ministry of Labor and Social Security of Republic of Turkey in the field of VET and briefed the participants about the OIC-OSHNET project. She also focused on various areas where joint projects and programs could be developed with OIC Member Countries.

30. Mr. Ousmane Ngom Leye (Senegal NFP) informed the meeting about the difficulties in vocational education and training in Senegal and the efforts to revise the TVET system. He stated the importance of improving and uplifting science and technology and the quality of education for sustainable development. He further stressed the need for expanding education, the classes and e-learning in order to provide new job opportunities to youth in Senegal.

31. Mrs. Hatice Ilbay Soylemez (SESRIC) informed the participants about an updated OIC-VET Portal and other infrastructural arrangements undertaken by SESRIC, namely OIC-VET Partners Database and OIC-VET Training Module. She further briefed the participants on the planned activities of SESRIC, namely the Skill Development for Youth Employment and OIC Human Resource Map projects and stressed the importance of and need for NFPs active support and contribution to those projects for their success.

32. The Meeting discussed several ways and means of enhancing cooperation and collaboration among the NFPs for continuous interaction and partnership and further discussed next steps and action points for consideration and implementation;

- Project based skills competition in the field of TVET among OIC Member Countries;
- Ranking the capabilities of OIC Member Countries based on some benchmarks, scientific advancements and standards;
- Establishing thematic working groups to work on Training of Trainers, Virtual Training and Simulation and Exchanging of Knowledge and Experience in VET.

### **Closing Session**

33. The Closing Session of the Third MAC Meeting was held on 18 July 2011. H.E Prof. Abdolraosul POURABBAS, Deputy Minister of Labor and Social Affairs and President of Technical and Vocational Training Organization (TVTO), made a closing statement at the Session. H.E. Prof. POURABBAS emphasized that in order to have sustainable development in skill and technology, the OIC-VET Programme would attach paramount importance to strengthening the cooperation of all beneficiaries, partners and social institutions to implement the projects in the best way. H.E. Prof. POURABBAS concluded his statement by thanking all delegations, OIC institutions, organizers and interpreters for their valuable contribution to the Third Meeting of the Monitoring and Advisory Committee.

### **Opening Statement by Prof. Abdolraosul POURABBAS, Deputy Minister of Labor and Social Affairs and President of Technical and Vocational Training Organization (TVTO)**

Praise be to Almighty God who sent divine revelations to the Prophet and opened a direct and eternal way before the humanity for evolution. Praise be to God who oriented human from the steep of ignorance and infidelity to the secure shelter of monotheism, science and knowledge.

#### **Ladies and Gentlemen**

#### **Respectable participants of the Third Meeting of Monitoring and Advisory Committee (MAC) of Vocational Educational and Training Programme for OIC Member Countries:**

Greetings

I would like to welcome the cherishing presence of distinguished guests to the Islamic Republic of Iran and wish you a happy and successful trip. This meeting is concurrent with the birth day anniversary of the saviour of humanity, Hz. Mahdi [A.S.] (The 12th Imam of Shiite) and I also wish to congratulate this auspicious birth anniversary to you.

While expressing thanks to the Republic of Turkey for holding the first and second meetings of Monitoring and Advisory Committee (MAC) of the vocational education and training programme of OIC member countries successfully, I would like to state that Islamic Republic of Iran welcomes the compilation of programs of Vocational Education and Training Programme for OIC Member Countries (OIC-VET) and will make its best efforts to fulfill it. The third meeting of Monitoring and Advisory Committee (MAC) of OIC Member Countries which is held for the first time independently indicate the special attention of the Islamic countries to skill trainings.

It is hoped that holding the third meeting hosted by Islamic Republic of Iran could be considered as new effort in achieving the long term objectives of Islamic countries in the path of developing skill learning. Reviewing the programs and achievements of OIC member countries on technical and vocational trainings, this meeting intends to follow up the subject of skill training based on necessities and priorities.

## **Ladies and Gentlemen;**

As you are aware, with the change of attitude of Islamic countries from the resource-based economy into to knowledge-based economy, and the significance of having access to sustainable development in these countries, the three pivots of 1) innovation, 2) technology and 3) merit have found considerable importance. Today, science, technology and innovation are recognized as pivots of economic growth and development, establishment of technological capability and development and welfare of countries. The improvement of merits and skills of human forces and promotion of their leaning abilities through life-long learning and also expansion of technical and vocational trainings are the most important tools of the policy of innovation and technology. On the other hand, the subject of entrepreneurship as a factor for orienting talents and expanding the capacity of resources of countries towards employment and sustainable development will need the empowerment of human forces and technical and vocational trainings are serving this goal.

Thus, considering the political, economic and geographical conditions of Islamic countries, compatibility of skill learning and technology system among Islamic countries seems to be necessary for the optimal use of abilities of these countries.

However, the broad and noticeable changes in the area of science and technology in Iran including success in the area of advanced technologies such as Nano Technology, biotechnology, robotics, approval of supportive rules such as supporting the knowledge-based companies, growth of journals, books and scientific-research articles at national and international levels, and gaining world ranks in the area of technology made Islamic Republic of Iran to move towards the system of skill and technology. Furthermore, studying the skill training systems of more than 80 countries, Iran has designed and compiled the National System of Skill and Technology with three sub-systems 1) skill and technology training 2) professional merit [qualification] and 3) employment system. The necessary rules such as Article 21 of the 5th Economic, Social and Cultural Development Plan as executive guarantees for its approval has also been approved.

Islamic Republic of Iran is pursuing the following objectives by designing and implementing this system:

- 1- Establishing a link between skill trainings and qualification and demands of labor market
- 2- Converging the skill training system with regard to the national comprehensive scientific map

3- Networking among active beneficiaries at the skill training system

4- Increasing the competitiveness of enterprises and training institutions and centers

5-Developing innovation abilities and national technology

6- Developing virtual and electronic education and training

The National Organization of Skill and Technology has been established within the framework of National System of Skill and Technology in order to plan and coordinate skill trainings. On this basis, the skill trainings in Iran have been designed in three levels: 1) general courses of skill and technology, 2) higher courses of skill and technology and 3) supplementary courses between academic levels. According to this system, the general courses of skill and technology are presented by Ministry of Education, higher courses of skill and technology at (A.Sc.), (B.Sc.), (M.Sc.) and (Ph.D.) are presented by Scientific and Applied Universities and the Technical and Vocational Centers and the supplementary courses between academic levels are presented by the Technical and Vocational Training Organization as well.

At present, in Iran, TVTO has 658 fixed technical and vocational training centers, 441 workplaces beside universities, 1800 work places beside industries and guilds, 2900 rural and tribal training bases, more than 1000 urban mobile training work places, 844 training work places in prisons, and 603 work places at military bases in the public sector and about 18000 free technical and vocational institutes in the private sector. They are working with about 36000 skill training instructors and in average 3 million people are granted skill certificate annually.

Also, in the part of academic skill trainings, it has 740 units of Scientific and Applied Comprehensive Universities in 712 fields with about 20000 instructors and 164 academic technical and vocational centers.

In line with these, having a successful experience with more than a century in the area of skill training, having specialized forces of skill system and capable organizations and associations, the Islamic Republic of Iran is ready to undertake the following proposals to achieve the above goals at the level of Islamic countries:

- Developing the regional system of professional qualification in the Islamic countries
- Compiling merit models for the pyramid of human force

- Holding skill Olympiad in Islamic countries with an emphasis on value-based technological skills
- Designing and implementing virtual, electronic and simulation training
- Developing skill learning for women in line with their empowerment as a half of our countries' human forces
- Training skill instructors for Islamic countries
- Developing skill learning for special and underprivileged stratum

In line with these objectives, I would like to request the President of the Meeting and Deputy of Technical and Vocational Training Organization of I.R. of Iran (His Excellency, Dr. Parand) to clarify strategies, objectives and proper grounds for the above-proposals in this Meeting in collaboration with other respectable members.

Last but not the least, I would like to thank and appreciate the collective efforts of the distinguished guests of the Third Meeting of the Monitoring and Advisory Committee (MAC) of the Vocational Education and Training Programme for OIC Member Countries (OIC-VET) and their presence in the Islamic Republic of Iran.

Relying on the Islamic values, it is hoped that the Islamic countries could be the manifestation of this divine command at the global level which states: **واعتصموا بحبل الله جميعا ولا تفرقوا** [Hold fast to the Rope of Allah, and be not divided [Holy Qur'an].

The İstanbul Declaration, adopted at that Economic Summit, stated the importance of vocational education and training in socio-economic development of the OIC member countries, welcomed the launch of OIC-VET and also requested Member Countries to facilitate the implementation of the programme. Marked by this event, SESRIC undertook the role of Executive OIC Organ of the OIC-VET Programme, responsible to develop and coordinate cooperation programmes among Member Countries and also follow up the implementation of these programmes. With the guidance of Monitoring and Advisory Committee and continuing support and involvement of the National Focal Points, since then, SESRIC has worked towards the successful implementation of the various projects under the framework of OIC-VET Programme. To this end, I am very proud to say that, three successful pilot projects have already been accomplished and have become full-fledged programmes under the umbrella of OIC-VET.

Our first pilot project with the Turkish Centre for Occupational Health and Safety (İSGÜM) in May 2010 has led the way to the successful establishment of OIC- Occupational Safety and Health Network (OIC-OSHNET) with a kick-off meeting one year later in May 2011. 3. The Committee **expressed** strong satisfaction with the implementation of OIC-VET Programme and **welcomed** the launching of planned projects to be implemented in coordination with National Focal Points of the Member States and concerned OIC Institutions.
4. The Committee **expressed** its appreciation for ISMEK Master Trainer Programme (İMTP) and **requested** Member States to actively get involved in the programme for sharing best practices among OIC Member Countries.
5. The Committee **endorsed** the OIC Occupational Safety and Health Network (OIC-OSHNET) and **urged** Member States to actively support the network for the exchange of knowledge and experience in the field of occupational safety and health.
6. The Committee **welcomed** the OIC International Students Internship Programme (OIC-ISIP), and **called upon** Member States to actively participate in the OIC-ISIP for promoting enhanced interaction among the universities, technical and vocational education organizations and the labour market.
7. The Committee **welcomed** the proposal to establish a thematic working group on the subject of “Virtual Training and Simulation” among the Member Countries. The working group will be led by

the Islamic Republic of Iran and open to the participation from all OIC Member Countries and relevant OIC Institutions a voluntary basis.

8. The Committee **welcomed** the proposal to establish a thematic working group on the subject of “Training of Trainers” among the Member Countries. The working group will be led by the Republic of Turkey and open to the participation from all OIC Member Countries and relevant OIC Institutions on a voluntary basis.

9. The Committee **welcomed** the proposal to establish a thematic working group on the subject of “Sharing of Best Practices in Vocational Education and Training (VET)” among the Member Countries. The working group will be led by the Islamic Republic of Pakistan and open to the participation from all OIC Member Countries and relevant OIC Institutions on a voluntary basis.

10. The Committee **requested** SESRIC to establish an e-mail group among National Focal Points to increase the level of participation and effectiveness of communication.

11. The Committee **welcomed** SESRIC’s project on Skill Development for Youth Employment (SDYE) and **appreciated** IDB’s contribution and support to this project.

12. The Committee **expressed** its strong appreciation for SESRIC for the prudent implementation of OIC-VET Programme and **requested** it to submit recommendations adopted at the Third Monitoring and Advisory Committee Meeting to the 27th session of COMCEC to be held on 17-20 October 2011 in Istanbul, Republic of Turkey.

13. The Committee **agreed** to give special considerations to assist Republic of Maldives in capacity building, resource sharing, and financing of the skills development projects of TVET due to the unique geographical and vulnerable economic situation of the country.

14. The Committee **expressed** its thanks and strong appreciation to Technical and Vocational Training Organization (TVTO) and Islamic Republic of Iran for organizing the Third Meeting of the Monitoring and Advisory Committee of the OIC-VET, in collaboration with SESRIC, on 17-18 July in Tehran, Islamic Republic of Iran.
