The working language of the meeting will be English, Arabic, French and Turkish.

#### **Information Desk**

The Information Desk located at the lobby of the Crowne Plaza İzmir will be at the service of the participants during 6-9 June from 09:00 to 18:00 hours daily.

# **3. Some Practical Information for Travel**

#### Local Time

The time in İzmir is GMT/UTC plus 2 (two) hours.

#### Electricity

The electric current in İzmir is 220 Volt, 50 Hz. Two-pin round plugs are used.

#### Weather

The climate of Izmir during summer can be easily characterized by its lengthy and sunny months. During June, temperatures in Izmir regularly exceed 30°C/86°F and can often top 35°C/95°F. However, the added humidity levels can make the climate feel even hotter.

#### **Currency Exchange**

The currency used in Turkey is 'Turkish Lira'. Convertible foreign country currency can be exchanged at the airport, hotels, exchange offices and at all banks in accordance with the current exchange rates announced daily. International credit cards are widely used.

#### Banks

Working hours for most of the banks are from Monday to Friday, 08:30 - 16:30. They are closed at weekends and at public holidays.



# **3. Some Practical Information for Travel, Con't**

#### **Driving License**

International Driving Licenses are recognized throughout Turkey. Car Rental Companies ask for a valid driving license.

#### Restaurants

For all participants, it will be an outstanding opportunity to taste various samples of Turkish, European, Asian and international cuisine in İzmir.

#### Shopping

Most shops in İzmir are generally open from 09:00 to 19:00, Monday to Saturday. Big shopping centers are open all through the week, usually from 10:00 to 22:00. In all shopping centers major credit cards are accepted and tax-free shopping is possible. You will also have the chance to do shopping in in the historical Kemeraltı or Kızlarağası Bazaars, which are located in the city center.

#### **Prayer Times**

You can obtain information on prayer times in İzmir during the meeting dates from the information desk which will be located at the Hotel lobby.



# 4. Accommodation

## **5. Transportation to the Hotels Area**

### Transfers of the participants from/to the Airport and to/from the Hotel will be ensured by the organisation.

#### İzmir Adnan Menderes Airport (ADB)

Venue of the meeting (the Swissôtel) is around 20 minutes (23km / 14.29miles) from the Airport.

- Transportation by airport cabs is approximately 35-40 TL.
- "Havaş" shuttle services are just in front of the hotel and costs 10 TL. Shuttle service starts to operate at 03.00 in the early morning till 23.30.
