The extent to which the NSOs can get adequate attention of their various stakeholders to the importance of quality statistics is a major challenge. Higher visibility together with a more extended outreach will result in the maximisation of the use of data produced by the NSOs. This Break-Out Session will put delegates in three groups to discuss initiating various Statistical Outreach and Awareness Competitions/Projects at both the national and the OIC level.

09:00 – 10:00 *Quality Management from an Institutional Perspective: Generic National Quality Assurance Framework*

This Session aims to present and discuss recent developments related to increasing the quality of the statistical production processes. Delegates of the OIC-StatCom will be briefed about the new concept of Generic National Quality Assurance Framework (NQAF), a formulation of the basic requirements of achieving good quality management in the National Statistical Organisations. OIC Member Countries will share their good practices, strategies and policies towards the development of national quality assurance frameworks for production of high-quality statistics.
